Client Terms and Conditions

Terms subject to change on individual client needs

** Travel Services: If we are coming to you on the day of event a well-lit area with natural lighting works best. Make-up application can take from thirty to sixty minutes. Hairstyling can take forty-five to sixty minutes. A minimum travel fee of \$100 per stylist will apply which will be determined by venue location.

** A minimum of \$200 in services will be required for booking. (\$300 minimum on holidays).

** A deposit of 50% is required to reserve your event date. This amount is non-transferrable and non-refundable. Your deposit will be deducted from the total amount of your event services. Payment of the deposit is payable by cash, credit or check. All major credit cards with the exclusion of American Express are accepted. The remaining balance will be accepted as cash or credit only.

**Cancellations can be made up to thirty days prior to event date with deposit non-refundable. If you cancel fourteen days or less prior to event date you are responsible for 100% of the quoted rate.

** A make-up trial is optional. If you decide to do a pre-wedding make-up trial we recommend that you do it no more than three months prior to event as skin tone changes seasonally.
